<sup>\*</sup>An individual is considered vaccinated if he/ she has been: a) fully vaccinated, i.e. has received the appropriate regimen of World Health Organisation Emergency Use Listing (WHO EUL) vaccines including their respective duration post-vaccination for the vaccine to be fully effective, and had their vaccination records ingested in MOH's national IT systems; b) recovered from COVID-19, or c) has obtained a negative result on a pre-event test taken in the past 24 hours before the expected end of the event.

^The provision for children 12 years and below (i.e. born in and after 2009) will only be applicable to higher-risk mask off activities and large-scale events, e.g. F&B dine-in, gyms.

- If there is more than one child aged 12 years and below in the group of 2 persons, both children must be from the same household. An individual aged more than 12 years may sit together with a child from a different household.
- For large-scale events, the number of children is capped at 20% of the actual event size.
