## PHASE THREE (HEIGHTENED ALERT) PRECAUTIONARY MEASURES FOR RELIGIOUS ACTIVITIES

On 10 June 2021, the Multi-Ministry Taskforce announced a two-step return to Phase Three (Heightened Alert) with effect from 14 June 2021. This document provides the conditions under which religious organisations (ROs) are permitted to carry out activities in places of worship.

#### PHASE THREE: HEIGHTENED ALERT

- 2. Under Phase Two (Heightened Alert), from 16 May through 13 June 2021, tighter measures were imposed on religious activities, namely a decrease in capacity for congregational and other worship services from 100 worshippers to 50 worshippers without pre-event testing (PET), no singing and playing of wind/brass instruments for live performance elements, suspension of all other non-congregational religious activities except for religious rites, and reduced capacity for marriage solemnizations as well as wakes, funerals and post-funeral rites.
- 3. With the return to Phase Three (Heightened Alert), the following allowances will apply for ROs:

## a. From 14 June

- Increase in the maximum permissible group size from 2 to no more than 5 persons;
- ii. Increase in capacity for congregational and other worship services from 100 to 250 worshippers with PET; and
- iii. Increase in capacity for solemnizations from 100 to 250 attendees with PET for all attendees.

## b. From 21 June

- Other non-congregational religious activities (e.g. religious classes) may resume;
- ii. Live performance elements (i.e. singing and playing of wind/brass instruments) permitted for congregational and other worship services as well as religious rites; and
- iii. Increased capacity for recording and broadcasting services.

## c. From 12 July

i. Increased capacity for live performance elements (i.e. singing and playing of wind/brass instruments) for congregational and other worship services as well as religious rites; and

ii. Increased capacity for recording and broadcasting services.

## d. From 19 July

- i. Reduced capacity for live performance elements (i.e. singing and playing of wind/brass instruments) for congregational and other worship services as well as religious rites; and
- ii. Reduced capacity for recording and broadcasting services.

<u>Annex A</u> summarizes the key changes for ROs going from Phase Two (Heightened Alert) to Phase Three (Heightened Alert).

## Worship Services

- 4. ROs may continue to conduct congregational and other worship services at places of worship without PET for up to 50 worshippers at a time (excluding religious and supporting workers<sup>1</sup>, whose numbers should be kept to a minimum), subject to safe management measures and the safe distancing capacity of the premises. From 14 June 2021, worshippers can participate in worship services in groups of no more than 5 persons (an increase from 2 persons today).
- 5. From 14 June 2021, ROs can conduct congregational and other worship services for more than 50 and up to 250 worshippers at a time, only if there is PET for all worshippers<sup>2</sup>.
  - a. Worshippers who have been vaccinated<sup>3</sup>, or have an exemption notice<sup>4</sup>, do not need to undergo PET.
  - b. Religious and supporting workers, and volunteers who have extended interaction with worshippers during the worship service, will need to undergo

PET. Those who have been vaccinated<sup>5</sup>, or have an exemption notice<sup>6</sup>, do not need to undergo PET.

<u>Annex B</u> contains the detailed PET requirements for compliance.

- 6. For congregational and other worship services beyond 50 and up to 250 worshippers with PET, ROs must segregate worshippers into zones, with each zone holding no more than 50 worshippers.
  - a. As there should be no mingling of individuals across zones, each zone must be completely separated from another by either a physical solid partition (at least 1.8m high if not floor-to-ceiling, from wall-to-wall); or at least 3m physical spacing demarcated by continuous physical barriers (e.g. rope barrier).
  - b. There must either be a separate ingress/egress for each zone or staggered entrance/exit timings so that worshippers from different zones do not mix with one another during entry/exit.
  - c. ROs must also take reasonable steps to ensure that worshippers do not cross the physical barrier (where applicable) or enter another zone that they are not assigned to.
- 7. ROs should continue to observe the following safe management measures for worship services (including services conducted with PET):
  - a. Keep worship services to as short a duration as possible. There must be no reception or mingling between worshippers, before, during or after each worship service.
  - b. All persons present (except children below 6 years of age) must **wear a face mask at all times**. Young children are strongly encouraged to use a mask or face shield, especially when they are in a group setting (e.g. attending worship service or religious class) or when interacting with others.

- c. Live performance elements are permitted during the worship service at places of worship<sup>8</sup>, with the necessary safe management measures in place (see <u>Annex C</u>).
  - i. A maximum of 30 persons are allowed to be involved in/support the conduct of the worship service. This includes persons on-stage, backstage or off-stage.
  - ii. There must be at least a 3-metre setback between persons involved in the conduct of live performance elements and worshippers.
  - iii. From 21 June 2021, up to 10 persons who are involved in the conduct of the worship service may unmask at any given time, of which up to 2 persons can be unmasked for singing or playing of wind/brass instruments. Persons should only unmask when required to perform their duties.
  - iv. From 12 July 2021, up to 10 persons who are involved in the conduct of the worship service may unmask at any given time, of which up to 5 persons can be unmasked for singing or playing of wind/brass instruments. Persons should only unmask when required to perform their duties.
  - v. From 19 July 2021, up to 10 persons who are involved in the conduct of the worship service may unmask at any given time, of which up to 2 persons can be unmasked for singing or playing of wind/brass instruments.
  - vi. For the safety of worshippers, we strongly encourage ROs to minimise the live performance elements for congregational and other worship services, such as shortening the duration of singing and the playing of wind/brass instruments during this period.
- d. No singing by worshippers, even with masks on.
- e. **No sharing of prayer and other common items** (e.g. holy books, passing of offertory baskets, prayer mats) as this increases the risk of COVID-19 transmission. Worshippers are to bring along their personal prayer items instead, where required.

f. Places of worship with reduced air circulation (e.g. enclosed prayer spaces, air-conditioned worship hall) should, where possible, open doors and windows to naturally **ventilate the space after each use**<sup>9</sup>.

## Marriage Solemnizations

- 8. From <u>14 June 2021</u>, ROs may continue to use places of worship to conduct marriage solemnizations where:
  - a. Solemnizations involving up to 50 attendees (including bride and groom): PET will not be required
  - b. Solemnizations involving 51 to 250 attendees (including bride and groom): PET will be required for all attendees.<sup>10</sup>
  - c. These activities are subject to safe management measures and the safe distancing capacity of the premises. The caps at paragraphs 8(a) and (b) exclude the solemnizer and religious and supporting workers, whose numbers should be kept to a minimum.
  - d. If the total number of attendees is more than 50 (including the wedding couple), they must still be segregated into zones of up to 50 persons each (see <u>paragraph 6</u> for zoning requirements). An individual attending the solemnization must remain within his or her respective assigned zone and must not enter an unassigned zone.
  - e. Attendees must maintain a 1-metre safe distance between groups except a core "wedding party" 11, which is allowed to comprise up to 20 persons (including the couple and their two witnesses). There should be no intermingling or mixing between groups nor between the "wedding party" and these other groups.
  - f. There must not be any reception with food and drinks, or wedding celebrations that are not essential religious rites.
  - g. ROs must also comply with prevailing safe management measures stipulated on the Ministry of Trade and Industry (MTI)'s website<sup>12</sup>.
- 9. Solemnizations at places of worship<sup>13</sup> may also involve live instrumental music (non-wind/brass) with the necessary safe management measures in place (see <u>Annex</u>

- <u>D</u>). Persons involved in/supporting the live instrumental music segment should be kept to the minimum. No other performances (e.g. singing, dance, variety act) are allowed.
- 10. ROs are encouraged to continue offering video link solemnizations as an option for couples.

## **Funerals**

- 11. Funerals, wakes, installation of niches and post-funeral rites<sup>14</sup> at places of worship can involve not more than 20 attendees<sup>15</sup> at any time and in groups of no more than 5 persons (excluding religious and supporting workers, whose numbers should be kept to a minimum), subject to safe management measures and the safe distancing capacity of the premises.
  - a. There must not be any reception with food and drinks.
  - b. ROs must also comply with prevailing safe management measures listed on MTI's website<sup>16</sup>.
- 12. Funerary-related activities at places of worship<sup>17</sup> may continue to involve live instrumental music (non-wind/brass) with the necessary safe management measures in place (see <u>Annex D</u>). Persons involved in/supporting the live instrumental music segment should be kept to the minimum. No other live performances (e.g. singing, dance, variety act) are allowed.
- 13. **Visits to columbaria at places of worship** should be kept as short as possible, with no mingling between groups of no more than 5 persons (an increase from 2 persons today).

### Other Religious Activities

- 14. From 14 June 2021, religious rites may be conducted in groups of 5 persons (increase from 2 persons today). Religious rites at places of worship<sup>18</sup> may also involve live performance elements subject to the safe management measures at Annex C.
- 15. From 21 June 2021, ROs may continue to use places of worship to conduct religious rites and resume other religious activities (e.g. religious classes for adults and children) so long as they are conducted in gatherings not exceeding

- **50 persons**, subject to safe distancing capacity and other safe management measures appropriate to the nature of the religious activity. This is also subject to the total premises cap of 150 persons for other religious activities (i.e. excluding congregational and other worship services) (see <u>paragraph 20</u>).
  - a. Each religious class must not exceed 50 persons, including the religious worker/teacher (and supporting workers, if any) with each group comprising no more than 5 persons. As a best practice, we encourage a greater separation of 2 metres between groups of students attending religious classes.

## Recording and Broadcast of Religious Services and Prayers

- 16. ROs are encouraged to continue supporting the religious needs of their communities via remote means such as recording and broadcast of religious services and prayers. ROs can have up to 15 persons on-location for these productions, of which up to 10 persons can be unmasked at any one time, with no more than 2 persons unmasked for singing and/or playing wind/brass instruments. ROs who wish to use their premises for digital recording or broadcast are required to notify through the CPRO website of (i) the planned dates of the digital productions; (ii) venue; and (iii) confirmation of adherence to the performers and crew limits, *before* conducting the digital productions.
- 17. From 21 June 2021, ROs can have up to 30 persons on-location for these productions, of which up to 10 persons can be unmasked at any one time, with no more than 2 persons unmasked for singing or playing wind/brass instruments. ROs need not notify MCCY/CPRO before proceeding with these productions.
- 18. From 12 July 2021, ROs can have up to 30 persons on-location for these productions, of which up to 10 persons can be unmasked at any one time, with no more than 5 persons unmasked for singing or playing wind/brass instruments. ROs need not notify MCCY/CPRO before proceeding with these productions.
- 19. From 19 July 2021, up to 10 persons who are involved in the conduct of the worship service may unmask at any given time, of which up to 2 persons can be unmasked for singing or playing of wind/brass instruments.
- 20. Those who are unmasked for singing and/or the playing of wind/brass instruments must maintain at least a 2-metre safe distance from other individuals. All other persons present must remain masked and maintain a 1-metre separation. The time spent on-location for this activity should be kept as short as possible. The production team must also put in place safe management measures, including nocross deployment between locations (where practicable), and thorough cleaning of technical equipment.

#### SAFE CAPACITY IN THE PLACE OF WORSHIP

- 21. All the permitted religious activities in <u>paragraphs 8 to 15</u> (i.e. excluding congregational and other worship services) may continue to take place concurrently at the place of worship subject to **a total premises cap of 150 persons**<sup>19</sup> subject to safe management measures and the safe distancing capacity of the premises and only if these activities can be conducted safely at separate locations within the place of worship, with no interaction between worshippers while entering, exiting or while in the premises.
- 22. From 21 June 2021, if there are 250 worshippers with PET in congregational and other worship services, ROs can accommodate no more than an additional 150 worshippers in non-congregational/worship services at the same time. For example, if there are 250 persons attending a worship service, as well as two religious classes involving 50 persons each, there can be at most another 50 persons taking part in other permitted religious activities<sup>20</sup> at the same time.
- 23. ROs are strongly encouraged to support the religious needs of their communities through remote means, as far as possible, in line with national guidelines to reduce social interactions, and thus minimise risk of COVID-19 transmission.
  - a. ROs should consider reducing other concurrent activities when congregational and other worship services are ongoing, so that there is a smaller total number of people on the premises at any one time, which will help to minimise the risk of large clusters from forming.

#### **DEPLOYMENT OF MANPOWER**

- 24. ROs should primarily engage their religious workers and staff to support the permitted religious activities but can deploy volunteers to support if necessary. The number of personnel involved in conducting each permitted activity should be kept to a minimum.
- 25. **Telecommuting remains the default for workplaces**, so as to minimise the number of religious workers and staff on-site. The religious workers and administrative staff should comply with prevailing workplace safe management measures stipulated by the Ministry of Manpower (MOM).<sup>21</sup> Restrictions against cross-deployment<sup>22</sup> across worksites remain in place.

## TRACETOGETHER AND SAFEENTRY

- 26. TraceTogether-only SafeEntry, where the TraceTogether App or Token is required for SafeEntry check-ins, is required at all venues that are required to implement SafeEntry<sup>23</sup>. ROs must make the necessary preparations to accept check-ins by the TraceTogether App or Token. ROs can refer to <a href="https://www.safeentry.gov.sg">www.safeentry.gov.sg</a> for FAQs, or more information on how to set up TraceTogether-only SafeEntry for their premises.
- 27. To provide quicker and more seamless check-in using the TraceTogether App or Token, all ROs conducting congregational and worship services are required to deploy the SafeEntry Gateway (SEGW) at their main entrances from 15 June 2021. ROs may deploy either the physical SEGW Box or use the SEGW function found in the latest version of the SafeEntry (Business) App based on their needs [Refer to https://go.gov.sg/gateway-overview for more information].

#### MANDATORY SUBMISSION OF SAFE MANAGEMENT PLANS

- 28. ROs that have not submitted their Safe Management Plans (SMPs) previously for Phase 3 will need to submit their plans, <u>at least 2 days</u> before commencing any activities outlined above. The detailed requirements and format for submitting these SMPs can be found at <u>www.cpro.gov.sg.</u> ROs, which have not acknowledged the updated conditions imposed on 14 June 2021, must do so at <u>www.cpro.gov.sg</u> before commencing the permitted activities.
- 29. MCCY reserves the right to suspend a RO's activities if there are gaps in the SMP submitted and until the necessary rectifications are made. ROs are responsible for the implementation of safe management measures and action could be taken for lapses and breaches. Should there be any confirmed COVID-19 cases linked to a RO's premises or place of worship, the premises may be closed for a period of time as determined by the authorities.

## **WORKING TOGETHER TO MAKE SINGAPORE COVID-SAFE**

30. The tightening of measures for religious activities reflect the seriousness of the current COVID-19 situation. We will have to remain vigilant and regularly refine our safe management measures in order to minimise the risk of COVID-19 transmission. MCCY will continue to work with our ROs to ensure a COVID-19 safe environment for religious activities.

## REQUIREMENTS FOR PRE-EVENT TESTING (PET)

## Where PET is required, the following must be complied with:

- a. ROs must ensure that all worshippers (except where paragraph (b) below applies) obtain a negative COVID-19 test result before they may be admitted into the venue where the service is being held.<sup>24</sup>
  - i. The test must be an MOH-approved COVID-19 test (either an Antigen Rapid Test (ART) or Polymerase Chain Reaction (PCR) test) administered by an approved test provider.<sup>25</sup>
  - ii. The test results are only valid for 24 hours from the time an individual registers at the testing premises to take the test. The RO must ensure that the result of the test is valid until the **end** of the worshipper's participation in the worship service.
  - iii. The worshipper must be able to produce proof of the test result, which are either (i) Check-in Successful banner (displayed on the SafeEntry (Business) application upon scanning with TraceTogether App/Token), (ii) COVID-19 Test Result Notice (ART), (iii) COVID-19 Test Result Notice (PCR), or (iv) Patient Risk Profile Portal (PRPP) ART Result Slip.
- b. The requirements for PET in paragraph (a) above do not apply to worshippers who have been vaccinated<sup>26</sup> or produce an exemption notice<sup>27</sup>. Before being admitted into the venue where the service is being held, the worshipper must produce valid documentation of either their vaccination or exemption notice which must remain valid until the end of the worshipper's participation in the service.
- c. Where PET is required for a service, ROs must prominently display signs at each point of entry and exit (including emergency exit) to the venue where the service is being held, to indicate:

- i. The space is a restricted place<sup>28</sup>, and the duration for which it will be a restricted place (i.e. the duration of the service). ROs must clearly mark the boundaries of the restricted place (e.g. though fencing, rope, signs, walls, partition, screen).
- ii. That entry and remaining within the restricted place is allowed only to individuals with a cleared status (i.e. have a valid negative COVID-19 test result notice, valid documentation of vaccination or exemption notice).
- d. ROs are to highlight to worshippers attending services beyond 50 and up to 250 worshippers that entry into the venue where the service is being held will be denied to worshippers who do not produce the relevant negative COVID-19 test result notice, vaccination notice, or exemption notice, with the necessary validity period.
